Material Information	United Projects for Aviation Services Company KSCP (the "Company") would like to report that, given the current exceptional circumstances due to the ongoing Corona virus pandemic, and due to the precautionary measures imposed to limit the spread of the new Corona virus, including the imposed closures of the airport, commercial malls and other related economic activities, which have negatively affected various sectors, including the real estate and aviation sectors associated with the Company's activities, the Company's operating revenue will therefore be negatively impacted during this phase.  In the same context, and due to the current economic crisis and the negative effects it has had on some small and medium businesses, the Company has decided to grant some rental relief by way of granting some rental waivers to its tenants in Discovery Mall.
