| <b>Material Information</b>  | <p>United Projects for Aviation Services Company KSCP would like to report the receipt of a notification of a lawsuit by its subsidiary – Royal Aviation Kuwait Company KSCC – for a financial claim as follows:</p> <p>The Directorate General of Civil Aviation (DGCA) raised lawsuit No. (2303/2019 Administrative 1) with the request to obligate a UPAC subsidiary - Royal Aviation Kuwait Company KSCC (the "<b>Company</b>") - to pay an amount of KD 3,782,829.297 (three million seven hundred eighty-two thousand eight hundred twenty-nine Kuwaiti dinars and fils 297 only) claiming a breach of the terms of the bidding No. (1-2003/2004) between the parties which is for the provision of technical and ground services for general aviation at Kuwait International Airport. Given the DGCA did not properly notify the Company with the aforementioned lawsuit, the court of first instance issued its ruling on the case and considered it "<b>null and void</b>" due to the failure of the DGCA to comply with the court's decision to follow the correct process to notify the Company. The DGCA has appealed the above-mentioned first instance judgment, with the request to cancel it and return the lawsuit to the court of first instance to decide on its subject. The Company has been notified of the next court of appeal session date which is scheduled on December 26, 2021.</p> |
