Developments that occurred to the disclosure	Reference to our previous disclosure announced on 07 th June 2023 with regards to Sheikh Saad Terminal (the "Project"), which is managed by a UPAC Subsidiary (Royal Aviation Kuwait Company KSCC), we would like to report on the progress of ongoing negotiations as the Directorate General of Civil Aviation ("DGCA") has expressed its willingness to extend the Project contract with Royal Aviation Company for an additional 6 months starting from 28 th June 2023 to 27 th December 2023 after obtaining the necessary approvals. The parties are currently engaged in ongoing discussions with regards to the administrative formalities of the proposed extension.
