Developments that occurred to the disclosure	With reference to the board of directors meeting held today, Thursday, 08 <sup>th</sup> August 2024, and our previous disclosure dated 13 <sup>th</sup> June 2023 regarding the signing of a loan agreement with the parent company (PWC Aviation Services Company KSCC) for a total amount of KWD 125 million, United Projects for Aviation Services Company KSCP (the "Company") hereby confirms that the board of directors has approved an increase to the limit of the existing facility/ loan provided by the parent company to KWD 160 million under an addendum to the aforementioned loan agreement, and has agreed to extend the maturity date for another year starting from the signing date. Moreover, the addendum has been signed by the Company following the board of directors meeting, pending final approval following the signature of the parent company to be deemed fully executed.
