

Developments that occurred to the disclosure	Further to our previous disclosure announced on 11 th August 2024 regarding the board of directors' approval to increase to the limit of the existing facility/ loan provided by the parent company to KWD 160 million under an addendum to loan agreement, United Projects for Aviation Services Company KSCP (the "Company") hereby confirms that, as of 30 th June 2024, the utilized portion of the loan amounts to KWD 132 million, and the unutilized portion of the loan amounts to KWD 28 million and will be used to meet additional financing requirements as needed.
