<b>Material Information</b>	With reference to the project concerning the construction and investment of the parking lot at Kuwait International Airport (T1) and its affiliated facilities (the " <b>Project</b> "), which is governed by a contract between United Projects for Aviation Services Company KSCP (the " <b>Company</b> ") and the Directorate General of Civil Aviation (" <b>DGCA</b> "), the Company hereby announces that it has received a notice letter from the DGCA, under which the DGCA has requested the Company to proceed with the handover of all Project sites by May 19, 2025.
<b>Significant Effect of the material information on the financial position of the company</b>	It will result in the cessation of revenues generated from the Project effective from the handover date. It is expected that the Company's annual revenues will decrease by approximately 7 million Kuwaiti Dinars as a result of the Project's conclusion and handover.
