

Material Information	With reference to the project concerning the construction and investment of the parking lot at Kuwait International Airport (T1) and its affiliated facilities (the "Project"), which is governed by a contract between United Projects for Aviation Services Company KSCP (the "Company") and the Directorate General of Civil Aviation ("DGCA"), the Company hereby announces that it has received a notice letter from the DGCA, under which the DGCA has requested the Company to proceed with the handover of all Project sites by May 19, 2025.
Significant Effect of the material information on the financial position of the company	It will result in the cessation of revenues generated from the Project effective from the handover date. It is expected that the Company's annual revenues will decrease by approximately 7 million Kuwaiti Dinars as a result of the Project's conclusion and handover.
