Developments that occurred to the disclosure	Reference to the Project for the provision of ground and technical services to the General Aviation Terminal at Kuwait International Airport - Sheikh Saad Al-Abdullah Terminal Project / Terminal 3 - (the "Project") which is managed by our Subsidiary (Royal Aviation Kuwait K.S.C.C), and further to our previous disclosure dated 23 <sup>rd</sup> June 2025, United Projects for Aviation Services Company K.S.C.P (the "Company") hereby announce that our Subsidiary has received an official letter from the Directorate General of Civil Aviation ("DGCA") requesting the initiation of procedures for the handover of the Project to commence effective today, Sunday, July 13, 2025.
The financial effect of the occurring developments (if any)	The end of the Project period and its handover to the DGCA will be reflected in the Company's consolidated financial statements, as Project revenues will cease effectively from the handover date. It is anticipated that the Company's consolidated revenues will decrease by approximately KWD 1 million annually.
