

Case subject matter	The Directorate General of Civil Aviation filed Lawsuit No. (2303/2019 Administrative/1) seeking an order obligating Royal Aviation Kuwait K.S.C.C - (a subsidiary of UPAC) - to pay the amount of KD 3,782,829.297 (three million, seven hundred and eighty-two thousand, eight hundred and twenty-nine Kuwaiti Dinars and 297 fils), on the grounds that the subsidiary breached the terms of Bidding Contract No. (1-2003/2004) relating to the provision of technical and ground handling services for general aviation at Kuwait International Airport.
Judgment date	23 December 2025
The court that issued the judgment - Circuit	The Court of First Instance Administrative/1
Parties of the case	Plaintiff: The President of Civil Aviation, in his official capacity. Defendant: The legal representative of Royal Aviation and another.
The Judgment is in favour of	The President of Civil Aviation, in his official capacity.
The Concluding Judgement of the Court of First Instance	In the original lawsuit, the Directorate General of Civil Aviation is entitled to KD 2,166,277.886 (two million, one hundred sixty-six thousand, two hundred seventy-seven Kuwaiti Dinars and 886 fils), while the subsidiary lawsuit was rejected.
The Concluding Judgement of the Court of Appeal	Not applicable at present.
The Concluding Judgement of the Court of Cassation	Not applicable at present.
The potential effect of the Judgement on the company	The ruling issued is a preliminary ruling issued by the court of first-instance, and the subsidiary intends to appeal it within the legally prescribed deadlines. The financial impact on the Company cannot be determined at this time.
